1. Call to Order

The meeting was officially called to order at 6:00 PM by Chair John Shelton.

5. Financial Update - Amanda Williams

- Amanda presented documentation that highlighted inconsistencies in their response and shared supporting evidence to counter certain claims.
- After a thorough discussion, the board came to consensus on the next course of action and agreed to draft a revised resolution to be included in the upcoming follow-up letter to Reading Edge.

7. Old Business

a. Governing Board Secretary

- The board discussed strategies to fill the vacant Secretary position.
- It was agreed that the role would be advertised during the upcoming Meet the Teacher Night, with the hope of recruiting a qualified parent representative to complete the board composition as outlined in the bylaws.

b. Fire Pump Update

- The long-awaited fire pump installation has been officially scheduled for the week of August 11.
- Board members expressed both relief and urgency, as the project has been delayed past its initial timeline.

- General discussion took place surrounding preparations for the start of the school year and continued collaboration with key staff and vendors.
- Board members expressed appreciation for the progress made so far and acknowledged the behind-the-scenes efforts from leadership, especially during such a pivotal transition.
